TERMS AND CONDITIONS

Please find below the full terms and conditions for the Mira Shower ‘Escapes’ Competition.

1. Eligibility

1.2 To claim your entry into the Promotion you must purchase, or have purchased, a Product, from the list contained at 1.1a above (the Product), from a retailer located in the UK, in a transaction between 3rd April 2023 – 28th May 2023 inclusive (the Promotional Period).

1.3 All other products are excluded. Purchases of the Product made outside the Promotional Period, or purchases of a second hand, refurbished or reconditioned, or counterfeit product, will not qualify.

1.4 You must be aged 18 or over and must be a resident in the UK. By submitting the form, you are deemed to have agreed to be bound by these terms and conditions.

2. Making a Submission

You will be entered into the draw for that week's prize. This prize draw will take place on the Monday following the end of the week. Submissions by fax or telephone will not be accepted. Illegible, incomplete or altered submission forms will be deemed void, as will submission forms not completed in accordance with these terms and conditions. Mira Showers will not accept proof of posting or transmission as proof of receipt of submission.

2.4 Please note that any Installer who makes a submission for themselves will be required to declare this promotion through their business per BIC.

3. Draw Entry

3.1 If you make a successful submission, you will be entered into the draw for that week's prize. There are 8 prizes across the 8 weeks, in which you can only submit a proof of purchase once, on your week of choice. The same receipt cannot be used for multiple entries. One entry per person can be submitted.

3.2 No responsibility can be accepted for entries not received for whatever reason.

3.3 The Promoter is not responsible for inaccurate prize details supplied to any entrant by any third party connected with this competition.

3.4 The Promoter reserves the right to cancel or amend the competition and these terms and conditions without notice for any reasonable reason. Any changes to the competition will be notified to entrants as soon as possible by the Promoter.
