Phytomenadione Vitamin K1 is antidotal. NOTE TO PHYSICIAN: Anticoagulant rodenticide. If swallowed, this material may reduce the clotting ability of the blood and cause bleeding. If ingested, administer vitamin K1 intramuscularly or orally. Vitamin K1 is antidotal at doses of 10-20 mg (not mgkg). Repeat as necessary based on monitoring of prothrombin times. Treat symptomatically.
